Attended Cremation Service

A funeral where family and friends have a ceremony, event or service in our chapel followed by a cremation. Service times for the chapels include time for arrival & departure.

All our prices for Cremation services include Administration, registration, environmental surcharge (set by Crematoria Abatement of Mercury Emissions Organisation), medical referee fees, ashes container (and the storage of ashes for up to one month), non-witnessed scattering of the ashes within the designated memorial gardens of Landican Crematorium or a disposal certificate.
